## STRUCTURED GIFT OPTION

In the interests of most responsibly stewarding donors' investments in this project, the Ponderosa Center Board of Directors have chosen to provide an option to structure pledges to this campaign in the following way.

1. The donor agrees to provide a 10% minimum initial payment of the total pledged amount upon his/her commitment of support and authorization for use of the funds for development costs related to the Ponderosa Center Capital Campaign.
2. Upon reaching \$10MM of committed pledges, the Ponderosa Center will request the outstanding balance of the donor's pledge to be paid in installments based on the donor's requested payment schedule.
3. The donor can request intallments to be paid over one (1) to five (5) years, in Monthly, Quarterly, Semi-Annual or Annual payments.

### Sample Gift Structure:

A pledge of \$1MM provides the initial contribution of \$100K. The balance of \$900k would be due once the Ponderosa Center organization meets the goal of \$10MM, over a period of four (4) years for an annual payment of \$225k.
