I'm excited to share the incredible strides the Ponderosa Center made in 2023, all thanks to your steadfast support. With your help, we secured funding for land acquisition, propelling our mission of nurturing arts, education, and community bonds.

In the spring of 2023, we welcomed Adam Haines through Boise State University's internship program, enriching our team with fresh perspectives and talents.

Last summer's "Tuesdays at the Terrace" concert series was a highlight, featuring eight performances that attracted an average of 400 guests per show. These events not only showcased local talent but also provided a vibrant platform for community engagement. The terrace was also utilized by local organizations for additional community and educational events.

Our partnership with St. Luke's brought an educational health series to the Glass House, offering valuable resources and fostering wellness within our community. Collaborations with local coffee shops like Cafe 634, Mountain Java, and Roseberry Coffee created welcoming spaces for residents to connect and learn from one another during the "off-season."

Furthermore, I'm thrilled to confirm our local partners' commitment to making our organization a staple in the community. The McCall Ski Heritage Foundation is creating eight historical exhibits for the center, preserving our region's rich heritage. With a new, larger home, the McCall Music Society will be able to host even more breathtaking performances. Additionally, the McCall Chamber of Commerce will be relocating its office to the Ponderosa Center, further solidifying our presence as a hub for community engagement and growth.

We're also proud to introduce our inaugural business membership level, a vital addition supporting our operations and programming. This initiative, coupled with the continued generosity of our Director Circle members, ensures the sustainability of our efforts.

As we continue our capital campaign into 2024, aiming to secure an additional \$6 million in funding, we're grateful for your ongoing support. Together, we can achieve the vision of building a home for our community and cultivate a lifetime of achievement through arts and education.







FINANCIAL COMMENTARY

Our focus for 2023 was gathering and telling the stories of how the Ponderosa Center will build Community and human Connection. We secured 100% of the funds to purchase the land; grew Terrace events and attendance by 100+ guests or 33% during the summer months versus 2022, averaging 400 guests per week; we introduced two new signature events series to engage in the Education pillar and Community pillar; developed a Business Leader Membership program to engage local businesses in our mission; secured our partnerships with the McCall Music Society, McCall Chamber of Commerce, and McCall Ski Heritage Foundation; and shared personal Ponderosa Center stories during Terrace, Community Relations, and Directors Circle events via board members and performers to build emotional connections. As a result, our revenue grew 37% from prior year and our net income grew 75% with careful management of our expenses, while investing to build the brand and expand our events and corresponding community awareness. Our overall cash position increased by 73% versus 2022, driven by generous donor support of our capital campaign to fund the land purchase. Through fundraising efforts and prudent management of our costs, we ended the year growing over prior year for the fifth straight year. This momentum and every donation help us advance our mission to enrich our mountain Community by ensuring Arts and Education are available to all. With gratitude, Kristi Thomasson
